2. THE UNAMIR C-L30 TOOK OFF THIS AFTERNOON WITH THREE HOLES IN THE BODY; BOTH SIDES VEHEMENTLY DENY SHOOTING AT THE PLANE OR FIRING THE MORTAR ROUND WHICH HIT THE AIRPORT JUST AFTER THE TAKEOFF. DALLAIRE NOW SUSPECTS A THIRD GROUP, TOTALLY OUT OF CONTROL OF CHIEFS OF STAFF, POSSIBLY DIRECTED BY

(UNAMIR NOW CONTROLS THE MERIDIAN WHICH IS VERY CLOSE TO THE GOR-RPF LINES AND IS PROTECTING 300 REFUGEES IN THE HOTEL. 3000 REMAIN IN THE STADIUM, MOSTLY OLDER PEOPLE AND ORPHANS). DALLAIRE HOPES THAT IF HE IS SUCCESSFUL IN NEGOTIATING A CEASE-FIRE, THE PARTIES CAN BE BROUGHT TO ADDRESS POLITICAL ISSUES. FOR THE MOMENT, DALLAIRE EXPECTS TO OPERATE ON BOTH THE CEASE-FIRE AND POLITICAL TRACKS, SINCE SRSG BOOH BOOH HAS NOT RETURNED FROM ARUSHA, AND MAY BE DELAYED UNTIL THE AIRPORT PROBLEM IS WORKED OUT.

5. IN RESPONSE TO AMB FLATEN'S QUESTIONS, DALLAIRE AMPLIFIED ON HIS PREVIOUS DESCRIPTION OF HOW HE WOULD USE AN EXPANDED FORCE. FIRST HE REPEATED THAT HE SAW THE FORCE AS A CHAPTER VI HUMANITARIAN OPERATION, USING FORCE ONLY TO ASSURE SAFE PASSAGE OF PERSONS AND ASSISTANCE. IN THE FIRST PHASE, WITHIN TWO WEEKS, HE WOULD AUGMENT THE GHANA BATTALION FROM ITS CURRENT STRENGTH TO A FULL 800 MEN TO SECURE THE AIRPORT AND THE UNAMIR HEADQUARTERS. THE NEXT STEP WOULD BE TO BRING IN TWO ADDITIONAL BATTALIONS, ONE WOULD WORK IN THE KIGALI AREA, REMOVE BARRIERS TO MOVEMENT, ASSURE THE MOVEMENT OF FOOD, AND PERMIT PEOPLE TO BEGIN TO MOVE FREELY IN AND AROUND KIGALI. WHEN ASKED HOW HE COULD DO THIS IN THE MIDDLE OF A WAR ZONE, HE REPLIED THAT HE IS ALREADY MOVING EASILY IN

KIGALI WITH THE AGREEMENT IN EACH CASE OF THE TWO PARTIES. THE ONLY PROBLEM HE HAS NOW, AND THAT HE SEEKS REINFORCEMENTS TO DEAL WITH ARE THE MILITIAS. THUS DALLAIRE ENVISAGES THE KIGALI BATTALION NOT BEING CHALLENGED BY EITHER THE ARMY OR THE RPF, GAINING PERMISSION FROM EACH TO ASSURE THE ACCOMPLISHMENT OF HIS HUMANITARIAN MISSION.

7. ON FOOD AID, DALLAIRE SAID THE RELIEF AGENCIES ARE READY TO MOVE FROM THE UGANDA SIDE, BUT ARE BEING DELAYED IN THE HOPE OF BEING ABLE TO PROVIDE A BALANCED DISTRIBUTION IN THE SOUTH WHICH IS STILL UNSAFE, APPARENTLY UNTIL THE ARRIVAL OF THE BATTALION FOR THE REGION.
