ITS GOOD RELATIONS WITH CHINA TO WEIGH IN WITH THE PRO ON THE TRIBUNAL ISSUE. LWENG CONFIRMED GOT SUPPORT FOR THE ESTABLISHMENT OF A UN WAR CRIMES TRIBUNAL FOR RWANDA AND ASSURED HE WOULD RELAY USG REQUEST TO HIS PRINCIPAL SECRETARY. LWENO ALSO NOTED THAT AN APPROACH TO THE CHINESE WOULD HAVE TO BE APPROVED BY FORMIN RWEGASIRA WHO HAS BEEN OUT OF TOWN ATTENDING A SADC SUMMIT IN BOTSWANA.
